## **November Meeting Minutes**

Meeting Open Time: 7:01 PM at the Brookline American Legion Hall and via Zoom. 7 members were present.

**Reading of the Minutes:** The Minutes of the October meeting were read. A motion was made by Chris Lussier to accept the Minutes as read; seconded by Greg d'Arbonne; and unanimously approved.

Post Quartermaster's Report: The Quartermaster's Report was read. The Post received \$10.85 from Interest; \$678.01 Poppy Donations (+ \$136.64 through VENMO); \$80,079.53 from Gate City Casino; and \$500 from Brookline American Legion Post 74 for Bruce Moran Memorial Bridge materials. Also, the Holiday Card Central remaining funds of \$1,709.28 were transferred back to the General Fund. Disbursements for the month were: \$2,000.00 for the Veterans Count event;

\$2,000.00 loan to American Legion Post 74 to cover the Monument Fund brick walkway installation partial payment to Earth Echo, LLC because the Post Legion treasure was unavailable to provide the funds (subsequently reimbursed by the Legion and will be reported in December report); \$220 for cleaning services; \$5,000.00 to Operation Care for Troops; \$25,000.00 contribution to Operation Delta Dog to sponsor 1 Vet and 1 Dog; \$80.00 to the Department of NH VFW for increasing the Quartermaster bond to \$70,000.00; \$327.95 for purchase of 2 gross of small flags; and \$497.48 the VENMO transfers to the Relief fund. The Holiday Card Central fund is now closed. Greg d'Arbonne made a motion that the Quartermaster's report be accepted as read, pending audit; seconded by Bruce Moran, and unanimously approved.

**Correspondence:** Thank you letter from Operation Care for Troops for our donation. Request for Girl Scouts requesting donations. VFW Bank Statements.

## **Committee Reports:**

- Patriot's Pen Program: George Robinson reported that there were no nominations for Teacher of the Year. He received 134 Patriot's Pen essays from the Hollis Brookline Middle School and 7 judges evaluated to identify the top nine to be submitted to District for judging (1 essay for every 15 received). Our Post selected a First Place Essay and to additional essays were tied for second. We will wait to announce the top three until after the District Judging is complete. George proposes to increase the awards by \$50.00 to \$150 for First Place and \$100 for the Second Place. Greg d'Arbonne made a motion to increase the awards as proposed, seconded by Bruce Moran. Discussion followed with regard to use of Al for Essay development. It was determined next year we identify method for detecting use of AI generation since there is a monetary reward for the contest. Motion was unanimously approved to increase the awards.
- Voice of Democracy programs: George proposes to increase the awards for this program since there are more efforts required for this submission. Greg d'Arbonne made a motion to award \$250.00 for First Place and \$150.00 for the Second Place and \$100.00 for Third place, seconded by Bruce Moran. Greg d'Arbonne made a motion to increase the awards as proposed, seconded by Bruce Moran. Motion was unanimously approved to increase the awards.
- George also proposes to invite winners to the Post meeting in January or February 2025 if we have anyone advance to State finals. He could write a news article to be posted on line to give the winners more recognition while also showing how the VFW Post is contributing to the community.
- Service Officer: Nothing to report.

**Membership:** Kerry Spangler was sworn in as Adjutant.

#### **Old Business:**

- Casino Fund Raiser for the Post: Chris
   Lussier is planning on writing an end-of-year
   letter to the Gate City Casino thanking them
   and showing what the Post has been doing
   with the funds with pictures.
- Chris Lussier will pay the church janitor \$50 for the cleanup of the church hall; after clearing up the confusion on who was paying.
- \$25,000.00 was presented to Operation
  Delta Dog. It was presented during a visit by
  members to observe a training session with
  3 Veterans with their dogs as well as a newly
  received dog in training. The donation was
  greatly appreciated.
- Greg d'Arbonne will draft a letter for review and then send it to the Towns' Welfare Departments in Hollis and Brookline and let them know that the Post will help cover any needs the Towns cannot provide for a Veteran or the spouse of a Veteran.
- Post donated \$5,000 to "Operation Care for the Troops" (OCT).
- The Annual "Support Our Soldiers" (SOS)
   event occurred 16 November where the Post
   purchased a table for ten attendees. Dr.
   Laura Landerman-Garber and Charlotte
   Troddyn to attend as our guests.

Remember National Home: Prayer was said for the National Home and residents.

**General Orders:** As distributed by the Department and District and posted on the Department website.

#### **New Business:**

- Jim Belanger indicated that the Zoom Meeting sound keeps cutting out during discussions primarily when noise occurs and it takes a few seconds to reset. Kerry Spangler will look into the problem.
- Jim Belanger as our website coordinator received a request from the Mesothelioma

and Veterans to add a link to their website from our website and they would donate \$40.00 to the Post. Jim posted the link to the website. Chris Lussier made a motion to provide the link to the website, seconded by Greg d'Arbonne. There is a concern about providing a link in exchange for money going against our policy about links on the website. It was stated there could be an expectation of reciprocity by receiving the money with no terms identified. We do not want to provide links to websites unless it is directly related to the business of our Post. There were also concerns with the validity and perceptions of supporting an organization on our website. The motion was unanimously disapproved and the link will be removed from the website.

 State Veteran's Advisory Committee is building a Global War on Terrorism monument at Boscawen Cemetery. They are selling bricks for \$250 to help fund the project. Greg d'Arbonne made the motion to purchase a brick that says "Hollis VFW Post 11373 for \$250.00 seconded by Bruce Moran and unanimously approved.

 Bruce Moran has to wear his knee brace for the remainder of the year and participate in physical therapy.  Steve Kolesnik, 97-year-old WWII veteran, is in Hospice Care at the Premier Rehabilitation Center in Nashua, NH.

- The Veteran's Day ceremony was a wonderful event attended by many folks and Colonel (Ret) Sandra "Sandy" Warde, USAF and DAR New Hampshire State Registrar participated as our guest speaker.
- The Four Vets and other members visited the Premier Rehabilitation Center in Nashua and sang the service songs to three veterans housed there. It was wonderful to watch the veterans sing along. Additionally, they sang the song "America" to another resident there at the request of one of her visitors and we watched her mouth the words as we sang. Sadly, the woman passed away about an hour later.
- Bruce Moran mentioned that a Marine veteran stopped by and offered to repair the hole in his garage roof for the price of materials only.

Closing: The meeting adjourned at 8:10 PM. The next meeting is 7:00 PM, Sunday, 15 December at the Brookline American Legion Hall, Brookline, NH and by Zoom.

There is an ongoing multi-district lawsuit against the manufacturers of firefighting foam and other PFAS containing materials used prevalently throughout the country, including on and around military installations, regardless of branch served in. The deadline for filing a suit is coming up in March 2025, and I will not be able to go in the field again like I did with Lejeune, but I am reaching out to dept. VSOs and Adjutants to spread the word and keep an eye out. If I can help, I certainly will, and if not, no worse for the wear. I just want to be sure someone who may have a case finds out of they do or not, rather than leave it on the table.
