# **February Meeting Minutes**

Meeting Open Time: 7:00 PM at the Brookline American Legion Hall and via Zoom. 8 members were present and no guests.

**Minutes:** A motion was made by Bruce Moran to dispense with the verbal reading of the Minutes since they were published in the newsletter; seconded by Bob Smith and unanimously approved.

Quartermaster's Report: The Quartermaster's Report was read. The Post received an EFT of \$7.00 from National, a shed donation for \$100, and \$2.47 in interest from the bank. There were seven disbursements, all Lowes debit purchases for shed building materials. Bruce Moran made a motion that the Quartermaster's report be accepted as read, pending audit; seconded by Andy Seremeth, and unanimously approved.

**Committee Reports:** Patriots' Pen certificates and gift cards are still being held by Chris Lussier and will be given to George Robinson at the first opportunity.

Membership: The members voted unanimously to accept John Kelly into the Post. John is a member at large in New Hampshire and gave his DD214 which contained the appropriate credentials. John currently works with Operation Delta Dog. Next, Chris Lussier made a motion to award Dr. Jim Kelly a Life Membership due to his continued deployments and status as an officer in our Post; seconded by Bruce Moran and unanimously approved.

- Jim Belanger stated he is still having some balance issues. His doctor fears it may be permanent. Jim is using a cane to assist with his vertigo. He will soon be having cataract surgery on one eye.

  time to present the check and a group of
  members will attend, to be determined.

NH Department requested a donation of \$50 from all posts to pay for a logo-emblazoned canopy for recruitment efforts. A motion to contribute was made by Bruce Moran, seconded by Chris Lussier and unanimously DISAPPROVED.

#### **New Business:**

 The American Legion has requested assistance with the heating oil bill (\$837.44) for the building. Bruce Moran moved to pay half the bill (\$418.72); seconded by Bob Smith and unanimously approved.

#### For the Good of the Order:

- Mark Andrews attended the Celebration of Life on 3 February in Texas for the MIA Captain on his POW/MIA bracelet. He detailed the experience of joining the family in this long-awaited closure.
- Mark Tigert described a workout program he attended at CrossFit that honored KIA Capt Ryan Phaneuf of Hudson.
- Chris Lussier gave a status report on the shed project. The interior is fully insulated, and sheetrock is now being ordered and will soon be mounted.


## VA to Expand Healthcare Eligibility on March 5, 2024

VA has announced that they are expanding healthcare eligibility to all veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, or any other combat zone after 9/11/2001. Originally, the PACT Act called for a phased in approach, but at the direction of President Biden, VA has instead opened this expanded eligibility to VA Healthcare effective March 5, 2024.

Please encourage any eligible veterans to enroll in VA healthcare; they can do so online at https://www.va.gov/health-care/apply/application/introduction, by phone at 877-222-8387, or by visiting a local VA medical facility.
