# **April Meeting Minutes**

Meeting Open Time: 7:00 PM at the Brookline American Legion Hall and via Zoom. 8 members were present.

**Minutes:** A motion was made by Bruce Moran to dispense with the verbal reading of the Minutes since they were published in the newsletter; seconded by Andy Seremeth and unanimously approved.

Quartermaster's Report: The Quartermaster's Report was read. There was one deposit for \$.99 from Interest. There were three disbursements; \$200 to the Brookline American Legion Post to pay for the VFW Post share of the electric bill; \$225 for two memberships voted on at the last meeting; and \$63.30 for building material for the shed. Bruce Moran made a

motion that the Quartermaster's report be accepted as read, pending audit; seconded by Andy Seremeth, and unanimously approved. The Quartermaster reminded the Trustees that after the meeting he needs them to sign the Quarterly Report of Audit.

#### **Committee Reports:**

- Service Officer: nothing to report.
- Patriots' Pen presentation will be on the 18th of June at the Middle School.
- George Robinson stated he ordered the Eagle Scout certificates. Greg d'Arbonne made a motion that the Post reimburses George in the amount of \$78.05 for the purchase of the certificates; seconded by Bruce Moran and unanimously approved.

Membership: Nothing to report.

#### **Comrade in Distress:**

 Bruce Moran stated his wife fell down the basement steps at their house and was severely injured. She broke her back, has lacerations on her head and it has affected her heart. Bruce says she is in a lot of pain and has pneumonia as well. Bruce says she is suffering tremendously even with the pain medications. He asks for everyone's prayers for Annmarie and his family during this crisis.

#### **Old Business:**

- Post Elections: Andy Seremeth made a motion that the Post Adjutant cast one vote for the slate of Officers nominated at the March meeting; seconded by Bruce Moran and unanimously approved. Greg d'Arbonne cast one ballot for the slate of Officers nominated at the March meeting. The Officers elected are:

- Memorial Day 2024:
  - George Robinson will be the Guest Speaker.
  - Chris Lussier stated he ordered the QR Code sign.
  - O Chris Lussier coordinated with Rabbi John who will do the Invocation and Benediction. They also discussed taking care of the Veterans graves at the Beth Abraham Cemetery in Nashua. Greg d'Arbonne made a motion that the Post do the graves there on 26 May at 1 PM; seconded by Chris and unanimously approved.

- Poppy Distribution Schedule: The Post will distribute Poppies at the Hollis Transfer Station from 8 AM to 4 PM. The schedule for volunteering is:

#### **Thank you from the AP Government Students**

Recently, our Post donated to the High School AP Government and Politics students who won the State level competitions with respect to the Constitution. They traveled to Washington DC last month to compete at that level. They needed donations to offset the cost of the trip and our Post made a \$1000 donation. The students returned from their trip, and while they did not win at the national level, they were very grateful to the Post for the donation. Mr. Duval, their teacher, sent the following note:

If I could please ask you for the favor of sharing this message with your members at your next meeting. On behalf of the AP Government and Politics students at Hollis Brookline High School, we again want to thank the members of the VFW for your financial support in our trip to Washington DC this month.

After 5 long days of competing and sightseeing (and LOTS of walking) the students are heading home.

The level of knowledge that these young men and women demonstrated this past weekend was truly remarkable. While we did not place or win any best unit awards, their poise, articulation, and knowledge were on full display, and wow. I do wish you all could have seen it. These are not just my words, but words from parents, alumni and other guests that got to witness them compete.

They also got to explore many of the sites in DC and the surrounding areas.

A Civil War battlefield (Bull Run / Manassas, an example of the ultimate lesson of what happens when government fails); Monuments to great individuals and movements that shaped our nation (Washington, Jefferson, Jackson, Lincoln, Franklin and Eleanor Roosevelt, MLK, Lafayette); Memorials to events great and tragic that shaped our national identity and remind us of the importance of good governance and the character of its people (Arlington National Cemetery, Marine Corps/Iwo Jima Memorial, World War I, World War II); Memorials to the things we should never, ever forget (Holocaust Museum, Pentagon 9/11 Memorial); Places that preserved our history for future generations to see and discover (US Botanical Gardens, Library of Congress, The National Archives- after all, a government class can't go to DC without seeing the Declaration of Independence, the Constitution or the Bill of Rights, right?).

And finally, to the seats of the 3 Branches themselves, from being outside of the Supreme Court as they hear arguments on a case that can impact the next several years (way too crowded to get in unfortunately) to the Halls of Congress, watching Members of the House debate legislation (and just what the rules of Congress are), seeing well known Senators conferring on the floor of the Senate to finally, touring the West Wing and peering into the Oval Office itself.

With all of this going on, many of these students also attempted to make time to study for other exams, do homework and continue to do the things that make them such successful students.

I feel truly lucky to have gotten to spend this time with such a great group.

### **News of Interest to Veterans**


#### Help Build the Veteran Database at the NH Veterans Heritage Learning Center


