# October 19th Meeting Minutes

**Meeting Open Time:** 7:00 PM at the Brookline American Legion Hall and via Zoom. 9 members and 1 guest were present.

Reading of the Minutes: A motion was made by Bruce Moran to dispense with the reading of the August meeting minutes since they were published in the September newsletter and sent to all members and that topics will be reviewed in the meeting. Greg d'Arbonne seconded the motion and it was unanimously approved.

Post Quartermaster's Report: The Report was read by Chris Lussier. General Fund account Deposits include: \$7.48 from Interest; Venmo Transfer at Old Home Days — \$19.58; Cash donations from Old Home Days — \$158.00; VFW electronic deposit — \$185.20; Transfer from VENMO account - \$575.56; total deposits \$945.82. Disbursements for the month were: \$429.50 for reimbursement for service day materials to Chris Lussier; \$400.00 to Michael

Papadopoulos for lift chair purchase for a veteran; \$320.00 to Patricia Dutra for cleaning services; and \$575.56 Transfer from VENMO to General Fund account - \$575.56. Total expenses \$1,725.06. Bruce Moran made a motion that the Quartermaster's report be accepted as read, pending audit; seconded by Greg d'Arbonne, and unanimously approved. The Quarterly Trustee report was reviewed and signed and submitted to Department.

**Committee/Program Reports:** Reporting is now accessed through the VFWNH.org website in the Login drop-down menu <Report Entry>.

- Service Officer: Several visits to visit a member in the hospital. Visits improved his demeanor from the first part of his stay to discharge.
- Patriot's Pen Program: We have about 130 entries narrowed down to 8 for final ranking in the post. We do not have online access to the contest application, so we need to find out how to register. Also, we are not clear as to how many essays we should submit (First Place, Top 3, top 8). Kerry Spangler will reach out to District to find the answer. (OPEN)

- Military Descendant Scholarship: George Robinson gave the announcement to the HBHS Guidance office for posting in Naviance as a scholarship opportunity. He will work that in December.

#### Americanism:

- 27 September VFW Member while performing with a band at a public brew-fest recognized all the Veterans in the audience and then led the entire audience in a singing of God Bless America.
- 25 September Four members met to rehearse music to be performed as an acapella quartet and a forthcoming Service Dog graduation ceremony.

#### Community Service:

- 8 September 6 Veterans visited Freddie's wonderful Historic Tavern, 28 Main Street, for wine, cheese, sodas, snacks and fun socializing.
- 20 September Bruce Moran, Kerry Spangler, and Chris Lussier participated in the Hollis Old Home Days parade presenting Chris Lussier's WWII era Willys.
- 3, 10, 17, and 24 September Weekly Veteran's Breakfasts in Hollis with numerous veterans from the community.
- 1, 8, and 15 October Weekly Veteran's Breakfasts in Hollis with numerous veterans from the community.

#### • Safety (Home/Fire):

 29 August – Two sets of handrails were installed on two sets of porch steps of a veteran's home ensuring safe access to yard area.

#### • Youth Activities:

 20 September – Several members talked with numerous kids about various facets of military service and life. Several recognized members from seeing us at the many school activities and programs we support. One of these was recognizing Chris as the "Old Flag Presentation" he has done many times over the years. Many stated that our interactions with them gave them a new perspective on the military.

#### • Legislative:

- 18 September Franklin Military and Veterans Campus Ribbon Cutting – Kelly Ayotte talked with 4 Vets on current happenings.
- 20 September Discussions with Liz Barbour about local veteran's programs and events

#### • Hospital:

- 3 October At three different times through the day three members (one each visit) visited a comrade at the rehab hospital (spread out through the day). One member assisted the physical therapist with the exercise routine: standing walking leg-lifts etc. The comrade showed significant improvement in both physical and emotional ways. The Post has spread the word to keep his spirits up through frequent visits by multiple members. The money spent was for a cranberry muffin which he shared with his wife.
- 5 October Two members visited comrade in the rehab hospital. Like the day before the patient did PT exercises with the assistance of the two members. We spotted him as he practiced standing with the walker. His attitude and health appear to be improving enormously.

#### • Teach Scout:

 20 September – Kerry Spangler and Chris Lussier instructed Scouts who participated in the Hollis Old Home Days Parade as the honor guard carrying the Colors and VFW Post Flag. The Scouts did a wonderful job.

#### • Homeless Veterans:

 18 September – 4 Members attended the Franklin Military and Veterans Campus Ribbon Cutting, tours and celebration.

#### National Home:

 19 October – Members approved a motion to donate \$250.00 to support the National Home.

#### Veterans and Military Support:

- 25 September Two members used Post wheelchair and walker to move Veteran from hospital to his home after his discharge. With help from a neighbor, we successfully moved him to his apartment and got him set up with his medication and instructions.
- 26 September Two members researched and bought a power lift chair for elderly veteran. We transported it using member's truck and trailer and delivered it to the elder Veteran's home. We then took a recliner from his home and moved it to the Legion Post building for storage.
- 29 September Member met with Dr. Landerman-Garber at her 'Card Central' location to discuss upcoming television appearance promoting her 'Holiday Cards 4 our Military Challenge. Member will offer insight to receiving cards while deployed (at the taping).
- 30 September Member petitioned staff at rehab center to provide a reclining chair for their VFW-member patient who requested one. Their rules limited the chair to one that is pleather or leather for purposes of sanitizing. Member is in pain from his recent accident and sleeps best in a recliner. A borrowed chair was located and delivered to his room. He is now much happier.
- 1 October Member attended a promotional TV-spot taping at WMUR TV Studios to inform and promote the local charity that collects and sends holiday cards to troops overseas.

#### Membership:

 20 Sep – Bruce Moran, Kerry Spangler, and Chris Lussier set up a membership table at

- the Hollis Old Home Days 20 September. We received information from 3 potential members.
- 19 October Sean Brady attended the meeting. (Editor's Note - A quorum was available on 5 November to vote on accepting Sean Brady as a member. Greg d'Arbonne made a motion to accept, seconded by Bruce Moran and unanimously approved.)

- Jim Belanger's daughter, Julie, passed away from ALS. Bruce Moran will send our condolences to the family.
- Mark Andrews friend, USAF veteran Bob Byrd passes away. We are requested to attend and provide the rifle detail to support the service on 29 October at 1400. Location is Hangar 91 at Nashua Airport. USAF is providing Flag and Taps detail. Mark Andrews, Chris Lussier, Bruce Moran, Greg d'Arbonne will provide the detail.

**Remember National Home:** Prayer was said for the National Home and residents.

**General Orders:** As distributed by the Department and District and posted on the Department website.

#### **Old Business:**

- At the June meeting, George Robinson stated that with the Nation's 250th Birthday coming up next year, the Post should purchase banners celebrating this event and place them at the major crossroads in both Towns, a total of 8 banners. George will investigate costs, what needs to be done and permissions that are needed. It was agreed that he attend the select board meeting to discuss.
  - George Robinson has not presented the 250th telephone pole banner idea to Hollis or Brookline yet because he wanted members to be aware of a better cost estimate before doing so. He requested a quote from a local vendor in Amherst, but doesn't have it, yet. He is also trying to track down the company that Bedford used for their town anniversary

- banners, which have held up well and retained their color for the last many months. The prices from online resources vary wildly. but the one he is most comfortable with is about \$145 per banner, including mounting hardware. That's about twice the cost anticipated when the idea was presented, so he doesn't think we should move forward with the offer to the towns until members can vote on an actual price...unless they're prepared to authorized "not to exceed \$1500 for 10 banners", which is a pretty high price tag. Quotes received ranged from \$1200 to \$4400. This does not include any costs associated with the DPW putting up the banners or the police escort to support the installation. Also, the town does not own the telephone poles. Chris Lussier made a motion to table this motion until decisions are made by the town 250th committees and determine how we may support the effort. Greg d'Arbonne seconded the motion and it was unanimously approved. (TABLED)
- Kerry Spangler proposed changes to the By-Laws to indicate meetings being the 3rd Sunday each month with the exception of June being the 4th Sunday because of the conflict with Father's Day. Jim Belanger seconded the motion and was unanimously approved. Kerry Spangler has drafted the changes and sent the draft with the monthly Newsletter for review for approval at the July meeting No comments received. Final copy will be signed and Kerry Spangler will take to the District 6 Meeting in August for District Approval. Editor's Note: Bylaws were submitted to Department Adjutant Paul Lloyd.) (OPEN)
- Kerry Spangler has developed a spreadsheet to use as a checklist for all events being worked by the Post. Assistance in identifying all the components of all events will be required. (OPEN)
- Chris Lussier and Kerry Spangler met with the Gate City Casino coordinator to get the final dates for the Hollis VFW charitable gaming the week of September 9th. (OPEN)
- Veterans Day Ceremony will begin at 11:00, November 11th at the Hollis Community Church at Memorial Square. Greg d;Arbonne will be the master of ceremony and Chris

Lussier will be the guest speaker. We also need to identify a guest speaker. It was recommended we keep the same timeframe and format as in the past Veteran's Day events. Greg d'Arbonne will be the Master of Ceremony, Chris Lussier will be the guest speaker. Chris will provide the PA, Greg will bring the lecturn. There are several activities at the schools with dates and times published in the October Newsletter. (OPEN)

- Inspection document preparations Our inspection will occur at the November 16th meeting at 6:00 PM. Chris Lussier and Kerry Spangler are assembling the binder for the inspection. (OPEN)

This would return us to what was done several years ago. Andy Seremeth seconded the motion and unanimously approved. (OPEN)

#### **New Business:**

- Bob Smith credited our visits to his speedy recovery after his fall. He requested a floor exercise cycle that is motorized. Greg d'Arbonne made a motion to purchase the machine \$72.89 for Bob, seconded by Bruce Moran and unanimously approved. Chris Lussier will order and deliver the machine.(OPEN)
- Chris Lussier will make the required donation to the VSO. (OPEN)
- Bruce Moran made a motion to purchase a table for 10 for \$2000.00 for the Easter Seals Veterans Count Gala fundraiser on 8 November. Motion was seconded by Chris Lussier and unanimously approved. Names to be provided to Bruce Moran. (OPEN)
- Kerry Spangler made a motion for the Post to donate \$250.00 to the National Home, seconded by Greg d'Arbonne and unanimously approved. (OPEN)
- Mark Andrews presented information on Operation High Flight, a non-profit organization to support veterans, children's hospitals, first responders and inner-city youth through mentoring and other activities. The operation is

looking for a store front and hangar space to support the program and is soliciting donations to support this program. They can sell flights as raffle prizes to help raise money for Veterans organizations. The VFW could buy flights and raffle them or give as gifts for \$125 to \$300. Mark Andrews made a motion to donate \$15,000 to help get the hangar space and store front set up for use, seconded by Greg d'Arbonne. After futher discussion, Greg d'Arbonne made a motion to table the discussion until the next meeting to better understand the method and means for support.

seconded by Mark Andrews and unanimously approved. (TABLED)
